## Update on Federal Bipartisan Infrastructure Bill

The House of Representatives did not vote on the \$1.2 trillion bipartisan infrastructure bill on Thursday, September 30, as was promised by Speaker Pelosi. Despite the pressure from AGC, CAWP, and other industry allies, there were not sufficient votes for passage. The reason for this is two-fold. First, Progressive Democrats in the House refused to vote on the infrastructure bill unless the \$3.5T so-called human infrastructure bill was approved first. Secondly, House Republican leadership provided no leeway for rank-in-file Republicans to support it.

A 30-day extension of surface transportation programs was signed into law over the

weekend, ending a day-long shutdown of some Transportation Department functions. House Speaker Nancy Pelosi and Senate Majority Leader Chuck Schumer said they want both the Senate's infrastructure bill and a reconciliation passed within that time frame.

Please be assured, CAWP and the AGC will continue our efforts to urge the House to pass the bipartisan infrastructure bill.

## Reminder: Overtime Eligibility Not Expanding Next Week

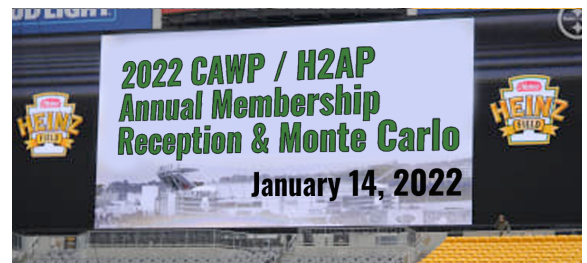


Employers planning for a long-anticipated expansion to overtime eligibility next week are being reminded that the proposal was in fact rescinded this past June. The regulation was first proposed by the Wolf Administration in June 2018 several years after the courts struck down a similar proposal from the Obama Administration.
