# Allegheny County Enacts Paid Sick Leave Requirement

Allegheny County Enacts Paid Sick Leave Requirement

Contractors working in Allegheny County should be aware of an ordinance requiring paid sick leave. On September 14, 2021, the Allegheny County Council approved a new paid sick leave ordinance requiring employers with 26 or more employees to provide paid sick leave to their employees.

The ordinance mandates that employees accrue one (1) hour of paid sick time for every 35 hours worked within the geographical boundaries of Allegheny County. Employees may accrue up to 40 hours of paid sick leave in a calendar year.

The ordinance's notice requirements are effective immediately, and the remainder of the ordinance takes effect 90 calendar days following the County's posting of the notice information for employers. Employers can be fined up to \$100 each time they violate the County Ordinance.

The City of Pittsburgh passed a similar ordinance, which went into effect in March 2020 and provides paid sick leave to eligible employees who work within the geographic boundaries of the City of Pittsburgh. While the City's ordinance exempts construction companies, the County's ordinance currently does not. However, the Association has joined with other construction associations in efforts

to include an exemption for the construction industry in the County's ordinance.

In the meantime, contractors working in Allegheny County should provide notice to their employees that they are entitled to paid sick time, the amount of the paid sick time (one hour of paid sick time is accrued for every 35 hours worked within the geographical boundaries of Allegheny County, and employees may accrue up to 40 hours of paid sick leave in a calendar year), and that retaliation against employees who request or use paid sick time is prohibited.

Future guidance on this issue will be provided by the Association.
