This certification program will review aggregate testing and general information necessary to qualify as a certified aggregate technician. This course will address the day-to-day testing, record keeping, and quality control requirements necessary for an aggregate to meet PennDOT specifications. This course will address inherent properties of aggregate materials that influence quality test results. It will also review PennDOT specification documents and procedures including actions resulting from quality failures.


