Upcoming Training: Confined Space Entry Competent Person

CAWP is offering Confined Space Entry - Competent Person training to prepare individuals to assume the role of Competent Person under OSHA's 1926 Subpart AA Standard (confined spaces). Specifically, attendees will learn the following:

- How to evaluate each project/jobsite for the presence of confined spaces.
- How to identify each space that is a confined space through consideration and evaluation of the elements of that space, including testing if necessary.
- How to identify existing and predictable hazards in the surroundings or working conditions which are unsanitary, hazardous, or dangerous.

- When and how to take prompt corrective measures to correct potentially dangerous working conditions.
- What are needed duties and responsibilities for reclassifying a "Permit Space" to a "Non-Permit Required Space."

In addition, attendees will obtain a working knowledge of testing procedures and equipment to be used to ensure preentry conditions are met and become familiar with the physical characteristics, configuration, and location of confined spaces potentially at each project/jobsite.
