# Safety Training Takes on a New Dimension with CAWP, Pitt IRISE

Experiencing true-to-life scenarios for health and safety training in highway work zones will soon be a (virtual) reality.

**BIG PICTURE:** Pitt IRISE and partners are developing an interactive and immersive training platform for the highway construction industry.

To create the Virtual Reality (VR) environment, researchers of the Pitt IRISE Program visited Golden Triangle's I-70/Route 51 project to take laser scans of the construction site to use in the development of this unique training program. CAWP would like to thank **Dave Sciullo of Golden Triangle Construction** for assisting with the project visit.

#### How it will work:

- Using VR, users will learn about the dangers caused by runovers, backovers, caught-in/caught-between and struck-by accidents.
- Users will be immersed in a detailed digital reproduction of a construction site.
- Hazards will be randomly placed inside the simulation for users to identify.

## What is the Pitt IRISE Consortium?

Part of the Civil Engineering Department at the University of Pittsburgh's School of Engineering, Pitt IRISE was developed to provide innovative solutions to highway infrastructure problems through collaboration between the public agencies that own and operate the infrastructure and the private companies that design and build it. Partners include PennDOT, the Turnpike, Allegheny County, Golden Triangle Construction, Michael Baker Construction, CDR Maguire, and CAWP.

CAWP's request to withdraw its grievance on the basis of the Settlement Agreement was approved by the PWAB on June 21, 2023.
