AGC of America, supported by a Susan Harwood Federal Training Grant, is pleased to offer a two-day VIRTUAL Fall Prevention in Construction safety training. Attendees will have the opportunity to earn continuing education credits (0.8 IACET CEUs).

Why Training is Needed:

- Construction workers make up approximately 5% of the country's workforce but account for an average of 19% of all job-related fatalities each year.
- Falls are the leading cause of death of construction workers.
- Falls accounted for 378 of the 986 construction fatalities in 2021.
- Fall protection was the most frequently cited OSHA standard in 2021.
