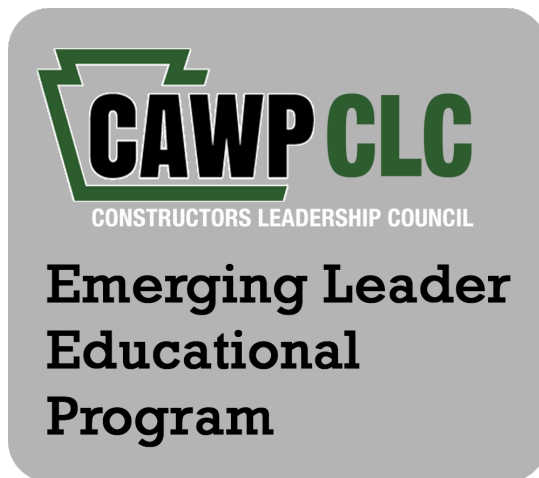

October 10 - Webinar: Practical Guide to Davis-Bacon and Related Acts Final Rule

U.S. Department of Labor (DOL) recently announced their massive final rule, "Updating the Davis-Bacon and Related Acts Regulations," with an effective date of October 23, 2023.

The application of the Davis-Bacon and Related Acts to federal and federally assisted construction projects leave many contractors uncertain about the requirements of federal prevailing wage laws and the consequences of non-compliance. The recent changes to the regulations are expected to add to this uncertainty. Failure to comply will place covered contractors at risk of catastrophic consequences, from losing money on contracts due to failure to understand labor costs, to high dollar back pay and related penalties, to debarment from future federal work.

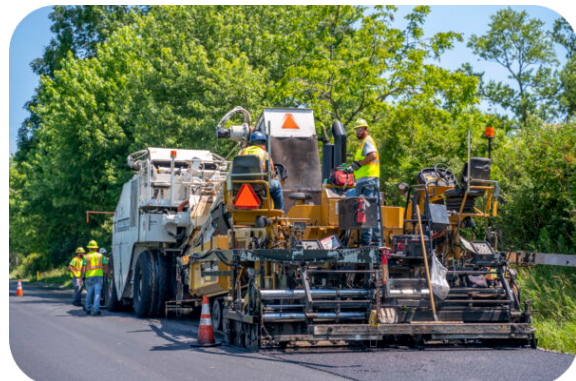

PennDOT/NECEPT Asphalt Technician Certification Program

PennDOT partners with the Northeast Center of Excellence for



Pavement Technology (NECEPT) to administer Asphalt Technician Certification programs to qualify technicians for state and federally funded construction projects. The Asphalt Technician course objectives are to provide a review of essential PennDOT specifications, operations, and procedures for asphalt paving, and provide certification testing.

Course Info:

All courses will be held from January to April 2024; exam retest dates are from April to May 2024. Most courses will be held virtually but there will be some in-person courses. In-person courses include one Asphalt Field Technician and one Asphalt Level 1 Plant Technician course. In addition, all the Superpave Volumetric Mix Design workshops will be held in-person.
