

EEO REMINDER: Distribution and Posting of Apprenticeship Programs/Dates

Federal EEO regulations* **require** contractors to take the following affirmative action steps regarding apprenticeship notices:

- 1. ** Send apprenticeship notices with cover letter to at least three (3) minority & female referral sources.
- 2. Post the apprenticeship notice on company bulletin boards (office

- and/or project site).
- 3. Conduct a toolbox talk or meeting to review apprenticeship opportunities.
- 4. Document steps 1-3 for your EEO files in the event your company is selected for a compliance review.
