## Affiliate Contractor Member

Affiliate Contractor members are contractor members of the Constructors Association of Western Pennsylvania (CAWP) and Contractors Association of Eastern Pennsylvania (CAEP). Minimum dues for Affiliate Contractor members are \$1,000, which covers volumes of work up to \$4 million. Dues for volumes above \$4 million are billed at 50 percent of the Active Membership rate reflected on the schedule above.

## Associate Member

Non-contracting firm. Dues are \$990 per year up to 200 Employees - \$1400 per year up to 500 employees - \$2400 per year above 500 employees. Applications for new membership must be accompanied by payment of first year's dues.
