CAWP Safety Training

Traffic Control Courses Scheduled

Traffic Control Technician (TCT) - An introduction to temporary traffic control in work zones for individuals who work in the field installing and removing traffic control devices. The course provides concepts, techniques and practice exercises in the installation and maintenance of traffic control devices.

Traffic Control Supervisor (TCS) - Designed to train those who will be actively involved in designing or setting up and maintaining temporary traffic control in a work zone. It moves from the concepts and techniques taught in the TCT course to the implementation of traffic control plans and techniques for installation and removal.
